TIME AND EXTENSION FOR DELAY:

The time allowed for execution of the works as specified in the Appendix or the extended time as approved by the department in accordance with these conditions shall be the essence of the Contract. The execution of the works shall commence after the Department Authority issues written orders to commence the work or from the date of handing over of the site, whichever is earlier. If the Contract or commits default in commencing the execution of the work as aforesaid, The Department Authority shall without prejudice to any other right or remedy be at liberty to terminate the contract and to de bar the contract or for a period of three years from participating in any tender invited by the Department Authority.

FORCE MAJEURE:

Any delays in or failure of the performance of either party herein shall not constitute default there under or give rise to any claim for damages, if any, to the extent such delays or failure of performance is caused by occurrences such as Act of god or the public enemy, expropriation or confiscation of facilities by Government authorities, or in compliance with any order or request of any Governmental authorities or due acts of war, rebellion or sabotage or fires, floods, explosions, riots or illegal joint strikes of all the workers of all the contractors.
