## Objectives

This workshop is part of a broader initiative to build a practical, city-level approach to assessing L&D, led by ICLEI South Asia and supported by the UNOPS Copenhagen Climate Centre. The main objectives of the workshop are:

- Learn from local experiences of L&D assessment and response.
- Reflect on how extreme heat and flooding have impacted lives, livelihoods, and culture.
- Identify current institutional mechanisms and where support is needed.
- Contribute to a locally grounded, action-oriented methodology that can inform city resilience efforts and global action.







### **Overview of the Project**

The project aims to enhance city-level capacities in assessing and managing climate-induced Loss and Damage (L&D), focusing on the cities of Ahmedabad and Surat. Climate hazards such as extreme heat and urban flooding have increasingly disrupted urban systems, causing economic and non-economic losses (ELD and NELD). Recognizing the urgent need for a localized, data-driven approach to assess the impacts of climate risks, this initiative seeks to generate actionable evidence from the ground up. Through multi-stakeholder engagement, this workshop aims to bring together municipal departments, parastatal agencies, and civil society actors to understand the existing city-level damage and loss assessments post extreme events. Potential areas for insight and information exchange, we will engage in the following broad categories to support structured discussions-

- 1. Post-Disaster Loss & Damage (Records & Datasets)
- 2. Loss and Damage Assessment Reports (Rapid/Detailed) at the district level
- 3. Capturing Non-Economic Loss & Damage
- 4. Health Data with respect to climate events
- 5. Urban Services Disruption
- 6. Vulnerable Communities and Social Impacts
- 7. Emergency Response & Institutional Roles
- 8. Coping mechanisms, Recovery efforts and Limits of Adaptation
